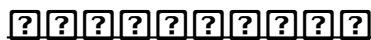

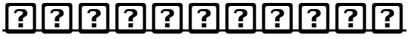
Thank you for choosing the R.O.C.K. Club - *Reaching Our Community's Kids*, for your child care needs. We extend the warmest welcome to you and your children. We are excited about getting to know you and your family; and it is our hope that this ministry is a blessing to you as we care for your children.

The R.O.C.K. Club offers an exciting alternative to filling your child's hours here at the center as well as outside of school. Our program is centered in a loving Christian environment. Our pre-school program encourages your child's progress by offering Kindergarten readiness activities. We also support your school aged child's progress by offering tutoring time and help with homework. Every child at the R.O.C.K. Club is given assistance in their spiritual development as we share basic Biblical principles.



Our vision is to serve the community of Radford by providing exceptional child care ages 3 - 12. This is accomplished through a balanced program that meets the needs of the whole child.

Our ministry will help equip children as they develop spiritually, intellectually, physically, socially, and emotionally. Proverbs 22:6 says *train up a child in the way he should go, and when he is old he will not depart from it.*



Our mission is to provide child care that supports the family structure for children ages 2 1/2 - 12, Monday through Friday, from 6:30 A.M. to 6:00 P.M. at the R.O.C.K. Club facilities.



In order to serve the families enrolled in the R.O.C.K. Club we have implemented the following programs:

Pre-School Programs:

- ! Full Time: This program is from 6:30 A.M. to 6:00 P.M. We provide breakfast, circle time, Bible lesson, organized recreation, kindergarten readiness activities, center time, a drink for lunch, rest time, art, snack, and free play.
- ! Part Time: This program is from 8:15 A.M. and 12:15 P.M. and will include circle time, Bible lesson, organized recreation, and kindergarten readiness activities. Part time spaces do not necessarily have to be during this time period. If another time suits you and it is not over 20 hours per week please talk to the director.

School Age Programs:

- ! After School Care: This program is for children in grades K through 6 and is from 3:00 P.M. to 6:00 P.M. We provide a snack, Bible lesson, organized recreation, free play, and tutoring.
- ! Before School Care: This program, opening each morning at 6:30 A.M., is for families with children in grades K through 6. We will provide a light breakfast and last minute help with homework.
- ! Before and After School Care: This program, for children in grades K through 6, combines the 2 programs listed above.

Each day, a parent or guardian is REQUIRED to walk their child into the main office of the R.O.C.K. Club and sign their child in. WE DO NOT ALLOW PARENTS TO DROP OFF CHILDREN ON THE SIDEWALK AND ALLOW THEM TO WALK IN ON THEIR OWN.

People who work with children are special people! Because of our commitment to young children, it is our goal to hire and secure staff whom possess the following criteria:

- ! Who love and want to work with young children
- ! Who have previous experience in child care
- ! Who are specially trained and educated in the field of child development
- ! Who have a minimum of a high school diploma (full time employees), or are pursuing a high school diploma (part time employees)
- ! Who love the Lord Jesus and have a deep dedication to Him
- ! Who are dedicated to the mission of our program
- ! Who are physically and mentally capable of working with young children
- ! There is always at least one staff member present in each classroom and on every trip who is certified by the American Red Cross in first Aid and CPR

Our facility is located at 1820 Second Street in the West End of Radford. The Radford Worship Center has freely given the program access to the fellowship hall, gymnasium, play ground and youth sanctuary for children's activities.

Enrollment is open to children between the ages of 3 & 12 regardless of race, creed, religion or national origin; and is available on a full-time, part-time and drop-in basis. Part-time and drop in enrollments are limited in availability. All enrolled families must complete an application, meet with the director, and tour the facility.

Children with special needs are a special enrollment consideration - the needs of the child come first and are paramount in the decision to enroll. If it is determined that the child's needs are outside the capabilities of our facility or staff, parents will be assisted by a referral to an alternative choice in care.

For school age children in Radford, transportation in the morning is by school bus. Each afternoon we will send our bus to Belle Heth & McHarg Elementary schools to pick up students. Simply send a note to school with your child saying that you want them to ride the R.O.C.K. Club bus. Pre-school students must be dropped off and picked up.

We will provide breakfast each morning for the school age children from 7:30 A.M. to 8:00 A.M. and for the preschoolers from 8:15 A.M. to 8:45 A.M. If your child is at the center for lunch they must bring a packed lunch. We will furnish a drink. If there is a time delay that ends up

becoming a closing please send a lunch. Each afternoon, the children receive a fun and healthy snack soon after they arrive.

The R.O.C.K. Club is devoted to providing individualized Christ-centered care for each child that attends. We believe that flexibility is a key in achieving that mission and therefore will fluctuate between 10 and 15 children to every one staff member. The pre-school. Our goal is to give children lots of love and support during the Club's hours.

We want children to feel safe comfortable and safe. Therefore, items such as blankets, pacifiers and stuffed animals are allowed from home for all pre-school age kids. However, in order to minimize the spreading of germs these items will only be allowed during designated rest time (see attached daily schedule).

School age children are allowed to bring cell phones that are provided by their parents. However, these phones must be TURNED OFF while attending R.O.C.K. Club. Any device that can record audio or video are not allowed to be used. Valuable items to a child, such as toys, video games and electronics are only allowed on Friday's and can be played with after snack and lesson have been completed.

As our program is based on meeting the needs of the whole child - intellectually, socially, emotionally, physically, and spiritually, we have set the following daily schedule.

Parents, please note that flexibility is a value that we cherish. Our schedule is designed to meet the children's needs and may change from time to time.

- 6:30 A.M.....Center opens
- 8:15 A.M.....Breakfast
- 8:45 A.M.....Breakfast cleanup and restroom
- 9:00 A.M.....Music and Movement
- 9:15 A.M.....Circle Time - Each day we will have a time where the entire group will come together and go over the calendar, weather, Pledge of Allegiance, and have a Bible lesson that will include Scripture, music, and an object lesson.
- 9:00 A.M.....Organized recreation in the gym or on the playground. On Fridays we will have Show & Tell during this time
- 9:45 A.M.....Small Groups - At this time we will divide the class into three groups. Each group is structured based on the child's development level, strengths, and areas where improvement is needed. We will focus on letters, numbers, colors, animals, art, and kindergarten readiness skills.
- 10:05 A.M.....Recreation either outside on the playground or in the gym
- 10:30 A.M.....Bible Lesson/Craft
- 11:15 A.M.....Lunch Time
- 11:50 A.M.....Clean up from lunch, use the bathroom, and get ready for rest time
- 12:15 P.M.....Rest time - Each child will have a mat to lie on and rest. Sleeping is encouraged by not required. If you do not want your

child to sleep, you may provide a soft toy for them to play with on their mat during this time.

1:45 P.M..... Recreation Time - Indoor and/or outdoor play.

2:30 P.M.....Bathroom, get ready for snack time

2:45 P.M.....Snack Time

3:00 P.M.....Free Reading Time

3:15 P.M.....Arts and Crafts

4:00 P.M.....Free Play Time

5:20 P.M.....Clean Up

5:30 P.M.....Music and Movement

6:00 P.M.....Go Home

We are aware that parents need and depend on consistent child-care for their child. We find that parents who are informed early about program closings have the ability to arrange for alternate care and their stress is reduced. The following is a list of program closings:

Holidays - the program closes for Labor Day, Memorial Day, July 4th, Good Friday, Thanksgiving Day and the day after. Closings for Christmas

and New Years will depend on what day of the week those holidays fall. We will let you know well in advance.

In case of severe weather we will post any delays or closings on WSL5 10 and WDBJ7

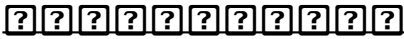
- ! Fees are due each Friday for the week we have just completed, unless you have already established a different payment plan with the director (i.e. every other week, once a month...). Fees paid are non-refundable.
- ! You will receive a one week grace period after the due date to make up your fees. If after that time you have not made a payment, your children will not be able to return. They may return as soon as a payment is made if the space is still available.
- ! Fees are due regardless of attendance. Each family will receive two weeks of vacation during the calendar year in which you will not be required to pay your fee. Please let us know of your vacation in advance so we may appropriately schedule our staff members.
- ! If a check is bounced, you will be charged \$20.00. If a second check is bounced, you will pay an additional \$20.00 and, from that point forward, will only be allowed to pay in cash.

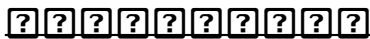
The 2 1/2 year old program does not require the children to be potty trained. However, once each child has turned 3 years old they will transition to the preschool class where potty training IS REQUIRED. We have designated potty and changing time every hour. If your child is not potty

trained, you are required to provide diapers and wipes. We will notify you when your child's supply of diapers and wipes are running low.



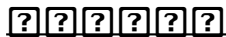
Since our program is housed in a space that is shared with the other ministries of the Radford Worship Center, we, unfortunately, do not have the latitude to operate past 6:00 p.m. To make sure we respect the other ministries using this facility we will charge one dollar for every minute past 6:00 p.m. your child is here.

We understand that sometimes things happen that are out of our control; therefore, each family will be given two opportunities before the charges will apply.



Prescription and over-the-counter medication and can be given. These medicines must be in their original containers. The R.O.C.K. Club has a form you must fill out detailing the dates and times to administer medication and any other special instructions. This form also gives staff the authority to dispense medicine to your child.

All medication will be kept in a locked box, and refrigerated if necessary. Only designated staff will dispense medication.

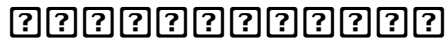


Healthy children are happy and productive. If your child arrives at the Club sick, the director will call and ask you to come pick up your child.

We will call you if your child has:

- ! A temperature of 100.1 or higher
- ! Diarrhea, Vomiting
- ! Unknown skin rash
- ! Sore throat
- ! Parasite infection (lice)
- ! Pink eye
- ! Difficult or rapid breathing
- ! Untreated infected skin patches
- ! Yellow skin or eyes
- ! Stiff neck
- ! Open wound

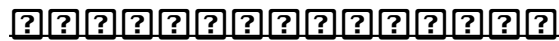
If your child becomes sick at the program, we will make every effort to comfort them until you arrive.



Hand washing is a critical part to maintaining good health. Children and staff will be encouraged to use good hygiene habits.

We will wash our hands:

- ! Before and after eating food of any kind
- ! After using the rest room
- ! Before and after administering first aid of any kind
- ! After any messy art project
- ! Any other time just to be safe



From time to time, children have small bumps and scrapes. Unfortunately this is a part of growing up. If your child has an accident at the R.O.C.K. Club, we will take the following steps:

1. Standard first aid will be administered immediately.
2. An accident report will be completed - a copy will be given to parents.

Guiding young children's behavior can be challenging. We believe that correction and guidance are Biblical and appropriate for training young children to become responsible adults. We believe that discipline should be fair, consistently applied, timely, and age appropriate.

Be assured that no form of physical punishment will ever be administered. Children will never be isolated in a confined space. Staff will never restrain a child or force a child to assume an uncomfortable position (unless physical restraint is necessary to prevent a child from running away or causing harm to him/herself and others). Our goal is to share and show the love of Christ in our discipline model.

Separating a child's care from the R.O.C.K. Club will not be an easy task. Our goal is to work with children who need help and guidance, but we are realistic and know that we may not be able to care for children who are self-destructive or endanger other children in the group. If either of these two situations occur, the staff will help parents find alternative care within two weeks.

The Radford Worship Center, as a responsible institution, does possess public liability insurance.

The R.O.C.K. Club has chosen to exercise the option to be exempt from licensing standards. Our program has filed the appropriate documentation with the Virginia Department of Social Services. Our program has met health, fire, and local sanitary inspections.
